Adoption of Ordinance O-1-23 - Amending Bowie City Code, Chapter 13, "Environmental Noise Control", to Amend Sec. 13-1 "Definitions" to Alter the Hours for Daytime and Nighttime, to Add Definitions of "Owner," "Plainly Audible", "Unreasonably Loud Noise" and "Receiving Property," and to Amend the Definition of Other Terms to Conform to the Definitions Thereof in State Regulations; to Amend Sec. 13-3 "Additional Noise" to Clarify Those Noises Eminating From Cars and Loud Speakers That are Violations of the Section; to Create Sec. 13-5 "Commercial Establishments Adjacent to Residential Property"; and to Amend Sec. 13-6 "Penalty" to Increase Certain Fines for Violations of Chapter 13. **(PH/EFA - Community Services Dept., ext. 3012)**
