## REGULAR CITY COUNCIL MEETING MINUTES

MONDAY, MARCH 16, 2015

### CALL MEETING TO ORDER:

The Regular Meeting of the Bowie City Council was held on Monday, March 16, 2015 in the Council Chambers at City Hall. Mayor Robinson called the meeting to order at 8:00 p.m.

### PLEDGE OF ALLEGIANCE TO THE FLAG:

Mayor Robinson led the Pledge of Allegiance to the Flag.

### QUORUM:

In attendance were Mayor Robinson, Mayor Pro Tem Truth, Councilmembers Brady, Gardner, Marcos, Polangin and Woolfley; City Manager Deutsch, Assistant City Manager Fitzwater, City Attorney Levan, City Clerk Hernandez, Staff, the Press, and the Public.

### CITIZEN PARTICIPATION:

1. Ms. Terry Morris spoke in regards to animal control issues in the Princeton Square neighborhood.

### CITY BOARDS AND COMMITTEES:

1. Councilmember Woolfley made a motion to appoint Ms. Heike Nyland to the Diversity Committee for a two-year term. Mayor Pro Tem Truth seconded the motion. Motion passed 7-0. Mayor Robinson swore-in Ms. Nyland to Diversity Committee.

### CITY MANAGER'S REPORT:

City Manager Deutsch reported: 1) City street sweeping began today, each neighborhood will be visited every 7 weeks between now and November; 2) Update on costs of winter storms that have occurred in the past weeks, up to 95% of the budget has been used.

### CONSENT AGENDA:

Councilmember Marcos moved the approval of Consent Agenda Items: A) Approval of March 2 Meeting Minutes; B) Approval of Proclamation P-3-15 Proclaiming April 2015 as Earth Month in Bowie; C) Approval of Resolution R-24-15 Approving the Appointment of Frederick C. Sussman as Counsel to the City of Bowie Ethics Commission; D) Introduction of Ordinance O-6-15 Amending the Bowie City Code, to Elect, Pursuant to MD. Code Ann., Labor and Emp. Art., §9-683.6, to Subject City Employees Covered by the Maryland Worker's Compensation Act Who Are Subject to §9-503 Thereof, and Their Dependents, to Sections 9-683.1 Through 9-683.5 of Said Article. Councilmember Brady seconded the motion and it carried 7-0.

**OLD BUSINESS:**

A. Approval of Ordinance O-4-15 Amending City Code Chapter 2, "Administration", Article V, "Public Ethics" to Add an Additional Alternate Member to the Bowie Ethics Commission, and Generally Relating to the Bowie Ethics Commission.

City Attorney Levan, summarized the staff report and recommends approval of Ordinance O-4-15.

**Public Hearing:**

Since there were no speakers signed up to speak, Mayor Robinson declared the public hearing to have been held.

Councilmember Polangin made a motion to approve Ordinance O-4-15 Adding an alternate member to the Bowie Ethics Commission. Mayor Pro Tem Trough seconded the motion and it carried unanimously.

**NEW BUSINESS:**

A. Alert Bowie 2.0 Presentation – Ms. Una Cooper, Communications Coordinator for the City briefed Council on the features and benefits of Alert Bowie 2.0. The City has offered the free alerting system to residents since 2006 which provides emergency alerts, public safety notices and informational messages to residents. As of March 11, 2015 there are 4,000 subscribers. The City is able to provide this service via a funding grant from the Department of Homeland Security.

Following comments from Councilmembers, Mayor Robinson thanked Ms. Cooper for the presentation.

**ADJOURNMENT AND MOVE TO CLOSE SESSION:**

Mayor Pro Tem Trough moved to adjourn the City Council meeting and move to Close Session under Statutory Authority to Close Session, State Government Article, §3-305(b)(7): To consult with counsel to obtain legal advice on a legal matter. Councilmember Brady seconded the motion and it carried 7-0. The meeting was adjourned at 9:09 p.m.

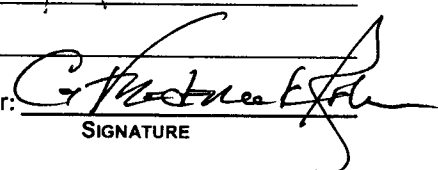
