Detailed Site Plan DSP-20003-02, Popeye's Restaurant at Mill Branch Crossing - The developer, Kuulipug, LLC, is requesting the City Council's approval recommendation regarding a Detailed Site Plan for a new 3,047 square foot eating and drinking establishment with drive-thru at Mill Branch Crossing. The subject property includes 1.05 acres and is located on parts of Outlots 9-10 on the west side of proposed Lola Drive, adjacent to US 301, in the CGO (Commercial General Office) Zone. **(PH/EFA - Planning & Sustainability Dept., ext. 3047)**
