REGULAR CITY COUNCIL MEETING MINUTES

MONDAY, MAY 4, 2020

CALL MEETING TO ORDER:

The Regular Meeting of the Bowie City Council was held on Monday, May 4, 2020 virtually. Mayor Adams called the meeting to order at 8:00 p.m.

PLEDGE OF ALLEGIANCE TO THE FLAG:

Mayor Adams led the Pledge of Allegiance to the Flag.

QUORUM:

In attendance were Mayor Adams, Councilmembers Boafu, Esteve, Gardner, Harrison, Ndebumadu and Woolfley, City Manager Lott, Assistant City Manager Mears, City Attorney Levan, City Clerk Hernandez, and Staff.

AGENDA ADDITIONS/DELETIONS/AMENDMENTS:

Mayor Pro Tem Boafu moved to add Resolution R-26-20 under New Business, Item B for discussion and approval. Councilmember Ndebumadu seconded the motion. Motion passed unanimously.

Councilmember Woolfley would like to add to the agenda for the May 18 meeting a discussion on the future of the Bowie IcePlex from the view of this Council as a whole.

COUNCIL ANNOUNCEMENTS:

Councilmember Harrison reminded residents to fill out the 2020 Census and announced that the City has partnered with Employ Prince George's and they will be helping to distribute the COVID-19 Hourly Employ Relief Fund to approved Bowie residents.

OLD BUSINESS:

A. FY2021 Budget, CIP and Constant Yield Tax Rate - Finance Director Matthews reported that municipalities are required by State law to place an advertisement in a local newspaper and to hold a public hearing on the Constant Yield Tax Rate. The City has complied with those requirements and is proposing to adopt a real property tax rate of \$0.40 per \$100 of assessment. This tax rate is 3.5% higher than the Constant Yield Rate and it will yield \$1,029,290 in additional property tax revenue for the City.

Since there were no more speakers signed up to speak, Mayor Adams declared the Public Hearing to have been held.

Councilmember Esteve made a motion to maintain the City's Property Tax Rate at \$.40 per \$100 of assessed value. Councilmember Gardner seconded the motion. Motion passed unanimously.

NEW BUSINESS:

A. Economic Development Committee - Mr. Sherman Ragland, Chair of the committee, discussed with Council the committee's plan to meet and prepare a proposal based on Council's recommendations, that could help Bowie businesses during the pandemic. Councilmember Ndebumadu submitted some suggestions of discussion to the committee which include the possibility of a fund of \$1.5M to \$2M, who will receive it, how much will each business get, what is considered a small business, will it be a loan or a donation, these are all topics that the committee will take into consideration during their meeting this week and come back before Council at a future meeting with the committee's recommendation for the program.

B. Resolution R-26-20 Concerning a Collaboration Between the City of Bowie and Bowie Town Center Restaurants to Provide Meals to the Essential Healthcare Workers Serving Larkin Chase Center – Mayor Pro Tem Bofo stated that he was approached by Larkin Chase Center for support in providing meals to their essential personnel during this pandemic. He has contacted several restaurants in the Bowie Town Center, and they are willing to work with the City in providing the meals. The funding would be coming out of the FY 2020 Budget.

Councilmember Harrison stated that the idea is great but has concerns that this could be setting a precedence for other facilities in Bowie to approach the City for support. Mayor Pro Tem Bofo responded that he does not think it will.

Councilmember Ndebumadu asked why the restaurants can't donate the meals or reach out to major corporations for them to collaborate on this partnership.

Mayor Pro Tem Bofo made a motion to state the amount not to exceed \$15,000 and have it open to include other senior facilities beside Larkin Chase that may need assistance in purchasing meals for essential healthcare workers. Councilmember Esteve seconded the motion. Councilmember

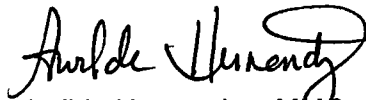
Harrison questioned the motion and motioned to table this item to the May 18 meeting. Councilmember Gardner seconded the motion. Motion failed 3-4(Adams, Boafo, Esteve, Ndebumadu).

Councilmmeber Ndebumadu made a motion to amend Mayor Pro Tem Boafo's original motion to state that we provide one week of meals to Larkin Chase in an amount of \$3,000, raise the total dollar amount to \$15,000 and be open to include other senior facilities in the City that may need assistance, and in the interim have staff and/or the Economic Development Committee work with outside corporations for their support to provide these meals. Money will come out of the FY 2020 budget. Councilmember Esteve seconded the motion. Motion passed 4-3 (Gardner, Harrison, Woolfley).

ADJOURNMENT:

Mayor Pro Tem Boafo moved to adjourn the Regular City Council meeting. Councilmember Woolfley seconded the motion. Motion passed unanimously. The meeting adjourned at 11:59 p.m.

Review of the Proposed FY 2021 Annual Budget

To: City of Bowie Council

Re: Proposed FY2021 Annual Budget

The Financial Advisory Committee (FAC) reviewed the City of Bowie's proposed budget for Fiscal Year 2021 (FY2021). The budget consistently provides for outstanding services to the City's residents. This attribute continues to make Bowie a desirable place to live. We wish to commend the City Council, City Manager, Finance Department Director and all associated staff and personnel for ensuring that the budget adheres to the City's Strategic Plan. For the 11th consecutive year, the budget contains a 0% real property tax rate increase.

The City has operated at a high level of financial efficiency over the years. The FAC understands and embraces the responsibility of reviewing and commenting on the proposed budget. The FY2021 proposed budget review was conducted with the intent to highlight benefits, identify concerns and to provide recommendations.

The focus areas include the following:

1. Community Services
2. Capital Improvements Program
3. Erosion of Fund Balance
4. COVID19 Impacts to FY2021 and Future Budgets

Community Services

General Overview

The FY2021 Proposed Budget continues to provide for a wide range of programs, services and facilities that maintain and enhance quality of life. Department of Community Services consumes 21.5% of the total proposed budget. It consumed 23% of the FY2020 total adopted budget. An expectation of increased efficiency within Building Maintenance is expected due to the centralization of positions, supervision and responsibility. The Gymnasium-Senior Center Campus concept and a collaboration between the Special Events Coordinator and Historic Properties Special Events Coordinator for events to attract non-traditional visitors are funded programs in FY2021.

Concerns: There are no concerns at this time.

Recommendations: Continue to provide services and programs that encourage interaction amongst all residents while adhering to the principles of fiscal responsibility and leveraging existing resources in creative ways.

Capital Improvements Program

General Overview

As in previous years, the City of Bowie continues to demonstrate that its citizenry is the foundation upon which community growth and financial well-being is based. The Capital Improvements Program (CIP) promises to continue the provision of essential services and amenities while maintaining a healthy balance in the financial outlook of the City.

The city completed several proposed projects in the last fiscal year, to include projects at the Senior Center and the Kenhill Center. These accomplishments are most evident in the nearly half million-dollar reduction in the CIP budget requirements from FY2020 to FY2021.

Golf Course

The City's due diligence and commitment to providing this amenity to the community is recognized. The patrons and surrounding community would appreciate seeing the course brought back to its well-maintained standard to the enjoyment of all golfers.

Concern: The restoration and modernization costs for the Golf course are a concern. If the Council agrees to this project, it calls for an investment of a little over \$12 million beginning FY2022 and spanning the next several years.

Allen Pond Park

Allen Pond Park is a well-utilized park in the City. It is home to many of Bowie's notable events, i.e. Bowiefest, the International Festival, and Summer Concert Series. It is also used by residents for exercise and enjoying nature.

Concern: As noted in a previous FAC letter, an expenditure of \$722,000 was budgeted for FY 2020. Follow-on work on this project for phase 1 through 3 (FY 2021-2023) was projected at \$6,615,000. This project has been delayed until FY 2023-2025 with a new cost estimate of approximately \$7 million for phase 1 thru 3. This is a highly valued and well-used park. Delaying necessary improvements increases the cost of a valued and attractive resource that should be maintained regularly to keep its value to the City and its residents.

Erosion of Fund Balance:

Concern: The greatest concern of the FY2021 proposed budget is the increased reliance on General Fund transfers coupled with the loss of intergovernmental and other revenues. The policy is to maintain the Fund Balance at 25% of expenditures. This requirement has been complied with for several years. In this proposed budget, there is a major risk as the trajectory of decline has become dangerously steep. The forecast is shown on pages 12 and 13 of the proposed budget.

- a. The FY2021 budget utilizes a larger percent of fund balance than any other year.
- b. The fund balance is projected to decrease to 1% of expenditures as early as 2023

The proposed budget is projecting operating levels that are unsustainable. Expenses are outpacing revenues:

- a. According to the proposed FY2021 budget, General Fund Expenditures are budgeted at \$66.3 million, an increase of approximately \$10 million from FY2020.
- b. According to the proposed FY2021 budget, revenues before the use of Fund Balance are projected at \$56,944,100. (Note: The revenue projections are not yet adjusted for possible declines due to collateral effects of COVID-19.)

Recommendation: Consider curtailing deficit spending by reducing expenditures or increasing revenue.

Table 1. Capital Improvements Program/Projects Fund Revenue

Table 1 illustrates the increasing reliance on transfers from the general fund and decreasing revenues from Intergovernmental Revenues

COVID19 Impacts to FY2021 and Future Budgets

While we applaud the proposed projects and their benefits to the Bowie Community, it is our belief that the probable changes in the recreation habits of the residents (due to COVID-19) will negatively impact the city's revenue and expenditure projections. We continue to have faith in our Mayor, City Manager and members of the City Council as they will have to navigate these new challenges in the coming fiscal year.

This letter and review of the FY2021 Proposed Budget is the result of the efforts of Mr. Rodney Yancey, Ms. Patricia Peterson, Ms. Tiffany Lightbourn, Ms. Meglan Knights, Mr. William Olukoya, and Mr. Carl Robinson, members of the City of Bowie's Financial Advisory Committee. We thank you for entrusting these residents with the responsibility to serve the City of Bowie's Council and residents.

Being a District 3 resident for the past 22 years, and after hearing statements made at last Mondays City Council meeting about the proposed Bowie Ice Complex, I have a couple of issues/questions that I would like discussed;

*Tax Base - Where is our primary tax base coming from to fund this type of project. Is it businesses, homeowners, contractors etc. I say this because Council member Henri Gardner mentioned citizen tax dollars already spent on this proposal. If this moves forward (which I oppose), it could end up costing citizens a considerable amount more in future taxes; due to the unknown additional costs in this Covid-19 environment we are in.

*Parks and Planning - After hearing from Parks and Planning at last Mondays City Council meeting, there appears to be issues with multipurpose complexes that have not been considered. At a minimum they should be raised and addressed before any decisions (on this proposed Complex or some other Alternative). I recommend that someone be brought back before the Council, as there are areas with this proposal that have not been properly vetted.

In summary, I think that Parks and Planning has to be brought back to get a total view of any impacts on decisions that we make concerning the Ice Complex. It's best to address any issues now, and not have to worry about any legal or monetary problems that the City might encounter in the future.

I am writing this letter as a very concerned District 3 resident of Bowie. This is in reference to The Proposed Real Property Tax increase recently brought to my attention . I would like to Highlight a couple of issues that I have with this;

*Covid-19 - This in itself, should be enough to cause a major problem/concern for Bowie citizens. I know that cities all over America are having budget shortfalls because of this; but with lockdown orders and people unable to generate income, a proposed tax increase on them shows a lack of empathy. The short and long term economic impacts are too unpredictable to consider an increase.

*2017 Tax Reform Act - This new Federal tax change caused a increase in taxes for a number of Maryland residents due to the limit on state and local taxes (SALT) that we used to be able to write off. This caused many Marylanders to pay Federal taxes as opposed to receiving a refund. I feel that now is not the time to take up any new tax proposals, considering this additional burden on Bowie citizens .

In summary, I find it shocking to even consider a tax increase at this time (There was a reason for Federal Multiple Stimulus Programs). I understand tax increases at certain times for specific reasons (ex. maintaining city services, establishing police department etc.); but this is just not the time. All expenditures should be looked at before any new tax proposals are taken under consideration.

The previous City Council meeting was very informative and I commend the Mayor and those council members who maintained their professionalism and extended courtesy to Mr. McNeal from the M-NCPPC. I assume that he was asked to present information that could be helpful to the council in considering potential alternatives to what is currently moving forward as a singular purpose ice rink. As tax-paying citizens we have a right and an obligation to speak up about matters whether we agree or disagree. I believe that we also owe each other the respect to hear opposing views and to respond professionally without interrupting another's comments and to respect opposing opinions. It may very well be the case that all Bowie residents had an opportunity to previously weigh in on the proposed ice complex. I know from having worked in local government for more than 30 years that more times than not, the average person may miss messaging about a proposal because of their busy lives going to work, raising children, caring for older parents and a host of other life concerns that people must deal with. That does not in any way diminish their right to express their views (for or against) a public matter, especially when there is a great likelihood that their pocketbooks will be impacted by a decision. After having read and heard some of the projections on this ice rink project it raises more questions than answers. For one, the projections offered by Councilperson Garner were far removed from the baseline projects as presented by Mr. McNeal who has managed the county's park system for more than 20 years. There is a disconnect with these projected returns that I believe should be revisited. Secondly, why would the city continue moving forward (stay the course) with a one sport concept when it is clear that a multi-plex approach is the industry standard and better serves the interest and needs of all residents? Whatever motivation is behind this pushback on what the citizens of the city truly desire is disheartening and disappointing. Finally, it appears that the city may be on the hook for funds already expended and contractual commitments to the contractor. (Although in my experience working on public projects there is always an out written into contracts in favor of the government. For example, if there is a decline in revenue for a project as originally projected.) If the city's financial involvement at this point is too great to abandoned the project; at least consider alternative designs. If we have to live with the decision lets at least get a better return on our tax dollars than a one-sport complex.

I have been a resident of the City of Bowie for 24 years. I moved here because of the peaceful setting, diverse population and excellent services delivered by the City. I realized at settlement for my home that as a resident I would be required to pay a special city tax in addition to that imposed by the State and the county. I was willing to do so for the amenities and services that came with the location. What I did not sign up for was to have my already high taxes increased to pay for a costly and unnecessary recreational facility for which there is no funding except through borrowing funding by way of issuing bonds. There are much greater priorities (i.e., schools, roadway improvements, senior housing) in the city than an ice skating rink. It is my understanding that the City Council insists on pushing through funding for this project amid COVID-19 when the state and the county have made it clear that there will be

significant funding cuts as a result of the economic fallout of this pandemic. Gov. Hogan has made it clear that the state's rainy-day fund is depleted and that there will be no new approved spending (such as the recently passed education initiative). My name is Kim Derocher and I am a Bowie resident of 50 years.

As a Bowie resident and current or former Bowie Hockey Club member, we are very excited about the new two-sheet Bowie IcePlex and the availability of additional ice time and new programs such as girl's ice hockey, adult leagues, more public sessions, and special skater programs for hockey and figure skating.

For the record, I'd like to say I support the two sheet ice facility, I have 4 children who are ice skaters, two are National level competitive ice skaters as members of Synchronized ice skating teams, the other 2 are hockey players.

These nationally competitive teams require hours of ice time each week to perfect their programs. The level of commitment from these skaters is second to none. Finding ice time for these programs is currently extremely difficult. We had a team of 18 skaters, who were between the ages of 12 and 18 years old, traveling up and down the COAST each week to squeeze in ice time. In a month's time, they traveled multiple times to Frederick, MD; York, PA; Harrington, DE; Reisterstown, MD; and Abingdon, MD, in order to get the time they required to skate together. Bowie was unable to offer any time as they were booked solid from 5:30 am until after midnight nearly every day.

I have heard an argument that because there are more NON RESIDENTS using the facility, they (fellow citizens of Bowie) are not able to justify the cost of the facility. Has anyone addressed the amount of money these families pay to participate in these programs, These groups don't skate for FREE. WE PAY FOR OUR TIME! And it is MUCH more than the amount paid for a Public Session. MOST of the cost is to pay for the ice time.

Between hockey practices and figure skating practices, required individual skating practice, and private lessons, skaters are on the ice multiple hours a week. Parents often drop their children off to head to local businesses to pass the time.

The second sheet of ice is STILL desperately needed in Bowie! My 6-year-old son had weekly Hockey practice at 6:45 am on Sundays, and my 16 yo had practice from 8:45 until 10 pm during the week. The second sheet of ice would give us the ability to schedule practice during NORMAL hours.

The GT has made a considerable and thorough effort to develop its own budget which is incorporated in the Planning Department's budget of the City's proposed FY21 budget. This budget will enable our work to continue which you have verbally supported during my annual presentation as well as by our 1:1 discussions.

Below are some examples of how this budget money will be spent:

- The Green Schools subgroup will host a workshop with Nancy Striniste, author and expert on natural playgrounds. The CEO of the Prince Georges County Public Schools, Dr. Monica Goldson, has asked to be included in this workshop. The City of Bowie has been recognized by the County school leaders for their support of our schools as they maintain their Green School certification;
- The Natural Resources subgroup will continue to remove invasive, non-native ivy which is killing trees specifically in Whitemarsh Park. The invasive plant has also infested various areas across the City as well. They will also continue to expand, maintain, and showcase their butterfly and other insect gardens in Bowie;
- The Food, Health and Wellness subgroup will continue promoting and educating the virtues of home composting and the positive effects plant based diets have on our bodies and on our environment;
- The Outreach subgroup will continue to provide an annual art exhibit and music performance to promote the environment;
- The Energy subgroup will continue to educate and promote ways to save energy through the use of renewable energy sources. They will also continue to work with the Business Operation Division to develop the City's Energy Plan; and
- The multi-modal subgroup will continue to work with staff to complete a connected trail system for recreation and commuting options.

With your support of the proposed budget, the GT's action plan which incorporates all the action items above, will be able to be implemented across the City of Bowie.

The GT's work is not insular, rather, it permeates throughout every City department, group, neighborhood, and entity of Bowie. The GT coordinates and collaborates on all types of activities with businesses, schools, religious organizations, non-profits, and various departments within the City government.

In collaboration with the Environmental Advisory Committee ("EAC"), the GT has created two documents - which we've shared with you before - are receiving kudos from within the County (County Council members and our County Executive Angela Alsobrooks) as well as from Sustainable Maryland. The Climate Action Plan ("CAP") and the Acts of Green are being hailed as timely and valued. The Acts of Green have been shared across all channels of social media for Earth Day/Month and have been positively received by all. The GT and the EAC stand out for having been the creators of these documents.

The GT has also worked with various members of the Staff Sustainability Team ("SST") to complete the Sustainability Plan goals and to create the CAP. As you may be aware, the SST will be responsible for fulfilling the CAP goals for the City. Once the CAP is approved by you, the GT and the EAC will continue to work with the SST to achieve the goals in measurable, efficient, and effective ways.

By supporting the proposed budget, we can keep on doing what we've been doing - always looking and forging ahead. We are doing our best to facilitate the vital changes needed to keep the City of Bowie on the cutting edge of sustainability practices and environmental actions.

We know that any unspent funds from one year will not carry over to the next. However, because of the coronavirus, we may not be able to spend the \$200 allocated to honor Bowie's Green Citizen of the Year. PLEASE honor those monies so they can be spent once the entities where we'll spend them will be open if not before June 30. I will come back to you to ask you to set aside time at a Council meeting when we can be there in person to honor this person. The name has not yet been announced.

As a group you've supported us verbally and with various pieces of policy. Now, this is the time to literally put your - actually OUR - money where your mouths are:) Please support funding our work for this next year.

Mayor Adams and City Council Members, thank you for the opportunity to submit a statement on behalf of the Bowie Community Media Corporation Board of Directors and its members. Our organization provides local television programming for City residents and the immediate surrounding area, and we are devoted to the charge of promoting diverse, entertaining, informative and educational programming to our viewership.

Our programming covers a wide variety of subject matters and topics including religion, informative talk shows highlighting the arts, mental and physical health care, veteran affairs, business opportunities and strategies, educational documentaries, domestic animal care, and teen/young adult interests. Our programming provides insight on the general world we live in and specific topics that are near and dear to the Bowie community.

Within the next three years, it is BCMC's goal to build upon our existing infrastructure and expand our programming and viewership while continuing to produce quality programs that are enlightening, engaging and uplift our community. Our goal includes expanding our current production space and equipment inventory, procuring additional staff and consultants, and using emerging technologies that will allow viewers to stream our shows on any digital platform. These goals are achievable with steady and continued leadership and financial support.

As an independent member-based organization, BCMC's funding is made possible through corporate membership fees and grants. The City has funded BCMC since conception and has made it possible for us to successfully manage our operational expenses. We are appreciative of the financial support provided thus far, particularly the additional funding provided to reboot our website. To that end, we were able to launch on May 1st our new and improved website at www.bcmctv.org, which showcases our programming content and the producers who make it possible. The website is a great start in laying a foundation for our marketing strategy, however, there is a lot more to be done to move us forward into the new millennium of television programming.

To build upon the existing infrastructure, we are looking to enlist additional human resources and consultants (on a temporary basis) to support operational requirements that include a robust marketing and social media campaign. We are also looking to purchase updated cameras, sound and lighting equipment for remote shoots, and may possibly add an additional editing suite option in our BCMC space to be manned by a BCMC tech editor resource. These are all items on our wish list as we look to attract seasoned local television producers and production quality shows that will further enhance programming options for our viewers. In addition, we are

hoping to set up a partnership with Bowie State University that will allow paid interns to support BCMC programming efforts while earning credits for graduation.

Once we've stabilized and strengthened our infrastructure, we will look to expand our platform to include online streaming directly from our website, while supporting current programming on our channel. Again, these plans are achievable and can be done within the timeframe posed, however, we will need continued support from our City partners and leaders to ensure we are ready for "primetime".

As the television industry as a whole continues to forge new heights in content accessibility, it is our hope the City will join us in this new vision for public access programming and moving us towards this new era. Thanks again for the opportunity to address this body and for your consideration.

I have been researching Belair's history since the 1970s. I grew up in Belair in the Chapel Forge section and am a Bowie High graduate. Bowie, Maryland will always be my hometown.

I am currently writing a book on the history of Belair At Bowie by Levitt & Sons - expected to see published in 2021 in time for Belair's 60th Anniversary. This book will detail the birth and development of Belair At Bowie and will address Levitt & Son's positive effect on the Bowie area during the 1960s. I believe the historic Welcome To Belair At Bowie, Maryland signage at the corners of Stonybrook and 450 and Belair and 450 are important to the recognition of Levitt & Son's contribution to Bowie history. 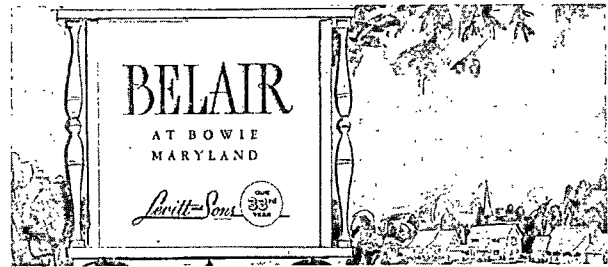

Good morning...I want to start by saying that, while I am not a resident of Bowie, I spent 22 years in the City of Bowie Museums...the last 12 of which were as the manager of same museums. Bowie history was, and is, important to me.

As you know, Bowie's history goes back to to the early 18century. But...not all of it's history is 18th or even 19th century history.

In 1961, William Levitt developed Belair at Bowie. In doing so, he created a unique neighborhood which remains as unique today as the day the first "settlers" in station wagons (instead of Conestoga wagons) moved in. Bowie remains a place to grow and prosper. It would seem that Mr. Levitt had a good idea. The entire concept of this wonderful community is remarkable in American popular culture today.

In 2021, "Levitt Bowie" will reach it's 60th Birthday. As part of that celebration, an effort is underway to install two "Belair at Bowie" signs, similar to the ones used by Levitt at Belair Dr. and 450, and at Stoneybrook and 450.

A citizen group has met with an exhibit designer - Adler Designs. Adler designed and installed the Belair at Bowie exhibit now at Kenhill. I was privileged to work with them on that project. They were wonderful to work with, and their designs are top notch.

I understand that the present state of affairs from the COVID19 virus has put many things on hold. However, given the light of this year's Belair at Bowie anniversary, I would respectfully ask the City to consider a proposal to pay for these signs. It's time that significant recognition be given to what Bowie started out to become, and which it still remains. We are BowieStrong!

Good evening Council, Mr. Mayor. I appreciate the opportunity to speak to you this evening, as a citizen and a member of the Environmental Advisory Committee – the EAC. My name is Stephen Wehrenberg and I have lived in Kenilworth for 29 years.

I plan to address three substantive issues, and a couple of inexpensive low-hanging-fruit opportunities.

First I will applaud and I hope reinforce your commitment to environmental issues as demonstrated by your Resolution of May 2nd to support the goals of the Paris Climate Accord and join with over 400 other city Mayors as part of the Climate Mayors network.

Part 1 UP

This calls for a dramatic reduction in greenhouse gas emissions, which has been codified in the draft Climate Action Plan which the EAC has submitted to staff, and has been posted on line for public comment. We had hoped for a public hearing in April, but our situation makes that impossible for now.

Second, I'll reiterate a few items that Gary Allen raised in his February 3rd presentation to the Council of the EAC's Next Steps for a Green Bowie.

We encourage you to adopt the Climate Action Plan after any adjustments made as a result of citizen input. We also recommended consideration of three new staff positions: a Chief Sustainability Officer, as has been created in a number of MD jurisdictions, to coordinate and leverage the portfolios of all city departments in meeting sustainability goals. Recognizing that the city's budget, already tight, will be further affected by the pandemic, an interim approach would be to better structure and codify the responsibilities and authority of the Staff Sustainability Team.

Bowie has already received praise and awards for sustainability and energy efficiency, but it will eventually have accomplished all that can be accomplished with city-owned assets and processes. That will not be enough to meet the state or county goals, nor those set by the Climate Action Plan. That will require the efforts of 21,000 Bowie households, and over 60,000 Bowie residents. A full time specialist focusing on outreach, education, and mobilizing our citizens will be crucial to meeting our goals.

The Trails Master Plan calls for a tightly integrated transportation network that accommodates automobiles, public transportation, bike, and pedestrian traffic, all of which should make it even more possible to live, work, play, and shop in Bowie.

Part 1 DOWN

Last on that list is a long standing goal to support the use of electric vehicles by creating the needed EV infrastructure. That is supported for future development by our Dig Once practices, but we need to go much farther.

Right now there is a proposal being staffed to take advantage of generous programs by BGE and the Maryland Energy Administration (the MEA). BGE is advancing Maryland's goal of 300,000 EVs on the road by 2025 by covering the costs of installing, maintaining, and supplying energy for up to four EV charging stations. I'll reiterate – FREE charging stations on City property, preferably City Hall. FREE to the city and FREE to users. Their purpose is to create even more incentives for EV use, and to do so with a visible signal to residents.

The other program on offer – by the MEA – is to install 2 FREE Level 2 EV charging stations that would be for the use of the City's fleet. The city would pay for the electricity, but if the city's vehicles are anything like my electric car, the cost of my electricity is about 11 dollars a month, or 4 cents a mile.

Part 2 UP

The county has taken advantage of these offers by having four FREE public charging stations near the main entrance to the County's Wayne Curry Administration Building, and four more for County vehicles in the side lot where County vehicles park.

This is the proposal enthusiastically promoted by the EAC for BGE's offer, since it demonstrates the city's commitment to our future in a visible way. I understand that a staff proposal to locate the FREE stations around the back of the police station in the lower left of this map has been rejected by BGE as too far from existing infrastructure and not visible enough from Evergreen Parkway to serve as a signal demonstrating the City's commitment to promoting EV use. I urge the council to direct staff to pursue this tremendous opportunity. The gain would far offset the loss of a couple of parking spaces – the incentive value is far greater than the existing incentive of reserved EV/hybrid parking spaces.

Part 2 DOWN

And I'll close with a couple of low-hanging fruit items. For a modest sum of about 4500 dollars, Bowie could field three styrofoam collection points which would be served by the Alliance of Foam Packaging Recyclers of Crofton. Last, for around 800 dollars you could install a water bottle refilling station in city hall – like that being installed in the police station – reducing the number of single use plastic bottles that are discarded, but more importantly serve as a visible example of the commitment of this Council and this City to a sustainable environment – improving the odds that the city and its residents will survive and thrive in the future.
